

worst situations, victims of abuse were trapped with their abusers during shelter-in-place protocols. Families hanging on by a thread have had an even tougher time keeping a grip on that thread.

Triangle Family Services quickly pivoted to virtual services to maintain connection with clients and continue implementing our programs in Family Safety, Financial Stability, and Mental Health.

What our staff and clients have shown us since the beginning of the pandemic can best be described as resilience. Like so many workers across the country, our staff have had to find ways to accomplish their work remotely often while simultaneously parenting children in virtual classrooms. Additionally, many of our clients have difficulty accessing our services virtually due to lack of internet or devices. Still, our team and those they serve pressed on.

Like many nonprofits, we took a financial hit due to the pandemic but despite the challenges and uncertainty we all faced, Triangle Family Services was still able to save our community over \$125 million.*

This fiscal year, we also took advantage of staff working remotely with limited use of our building to proceed with much needed deferred maintenance. Staff and clients will return to a brighter, safer space with improved air quality and virus protection as well as energy efficient features that will yield cost-savings for years to come.

"I have the privilege of working with the Latinx community and recently provided online Mental Health counseling to a child experiencing symptoms of PTSD due to sexual abuse. While the child was in treatment. I learned that another family member was struggling with their own trauma. Because of TFS' comprehensive, whole family approach, I was able to connect them with a colleague so they could receive counseling as well, without presenting the additional barrier of having to engage with a separate agency. With only two cell phones available to them, they worked hard to make it to our virtual sessions. They each showed incredible resilience, putting one foot in front of the other. Because I was able to build trust with this family, they eventually referred others from their community to our agency. This speaks to the power of our mission — the ripple effect of helping a single family can impact a whole community."

In partnership with Wake County, using CARES Act funding, we opened and operated a hotel for homeless individuals for six months, ultimately helping 162 people find housing through comprehensive case and care management. (select clients pictured below)

We impact neighborhoods, helping people stay in their homes and giving individuals opportunities and tools to move from homelessness to housing.



Average individual annual cost of homelessness across three systems:

\$150,000

This calculation is based on 3–5 ER visits/year + annual cost of jail or shelter.



"In our **Financial Stability** programs, we work with clients who have lost or are on the verge of losing housing — for many it seems like they have hit rock bottom. Our services teach clients how to leverage trauma, lack of resources, and vulnerabilities to adapt and rebound from a crisis. 

Grants & Contracts* \$4,118,488


