If the securities are mailed to Triangle Family Services, the gift date is the date of the mailing (recommend sending by registered mail). Stock market fluctuations after the date of delivery (as defined above) will not affect the charitable deduction for tax purposes.

Triangle Family Services will sell stock as soon as possible (usually by the business day following the receipt of the stock). The net proceeds will be affected by the actual sale price, as well as a broker charge to process the transaction. Accordingly, there will be a variance between the charitable deduction amount and the net proceeds applied from the gift. Triangle Family Services cannot be responsible for any variance in these amounts.
